Restatement of Professional Enhancement Opportunity:

I attended the 59th Annual Southeastern Regional Association of Teacher Educators (SRATE) Conference in Little Rock, Arkansas October 24-27, 2012. I presented two separate sessions while attending the conference.

- Learning, Innovation & Technology: The Flipped Classroom
 I presented a PowerPoint presentation that shared the concept, its application, and student responses to the format from one of my Adolescent Development courses taught the previous spring. The PowerPoint presentation was followed with group discussion and a questions and answer session.
- Reading Teaching Efficacy Belief in Alternative Teacher Licensure Candidates
 The results of my approved research proposal by the same name conducted in spring
 2012 was shared with the participants. The outcome of this study indicated that the
 course content and field experience along with critical reflection helped Master of Arts
 in Teaching pre-service teachers enrolled in MAMS 5333: Teaching Literacy in the
 Content Area, moved forward in their thinking and the practice of reading.

Brief Review of Professional Enhancement Opportunity:

As a Board Member of ArATE I help to staff the Registration Table and attended numerous sessions. These sessions included sessions on technology and course delivery, increased course interaction, synchronous and asynchronous instruction, teacher effectiveness in the profession, teacher efficacy, and non-traditional teacher preparation.

Summary of Findings, Outcomes and Experiences:

This was a great opportunity to both attend and present at a regional conference.

Many of the sessions that I attended discussed research and study activities that lead to more effective programs in education. It was a positive opportunity professional growth activity. I found the research that I have been conducting is most relevant and was well accepted.
