B. Restatement of Professional Activity

Code Blue: Not for You? ACLS for Nurse Educators

This professional presentation was approved and presented as a 2 ½ hour educational session at the 2015 Nurse Educator's Conference in the Rockies in July in Breckenridge, Colorado. The overall goals of this offering were to provided non-critical care nurse educators with the knowledge needed to participate in the education of students should a "code blue" occur on their unit as well as the needed knowledge to discuss and debrief with students post code. The Advanced Cardiac Life Support guidelines approved by the American Heart Association served as the guidelines for instruction and provided nurse educators with the needed knowledge to improve patient outcomes.
