A. Curricular Items (to be considered at the December 5, 2002, meeting of the Curriculum Committee)

Department of Business and Economics

1. Delete footnote 4 which states "At least ten hours of electives must be above the 1000 -level" from the degree requirements for the Management and Marketing degree program.

Department of Curriculum and Instruction

1. Delete ECED 3013, Technology in the Early Childhood Classroom, MLED 3081, MLED 3081, Instructional Technology, and SEED 3702, Introduction to Educational Technology, from the required curricula and course descriptions and add EDMD 3013, Integrating Instructional Technology, to the course descriptions and required curricula in Early Childhood Education, Middle Level Education, and Secondary Education.
2. Allow students in the Early Childhood Education and Middle Level Education programs to complete either GEOL 1004, Essentials of Early Science, or GEOL 1014, Physical Geology, in the required curricula.
3. Delete COMS 1003, Introduction to Computer Based Systems, from the required curricula in Middle Level Education in English/Social Studies and Mathematics/Science and add three hours of electives to the English/Social Studies curriculum and one hour of elective to the Mathematics/Science curriculum.
4. Change the course number of MLED 2001, Introduction to Education, to MLED 2002 and change the course description and delete MLED 2011, History of Education, from the required curricula in Middle Level Education (both options) and from the course descriptions.
5. Delete MLED 3051, School Law, from the required curricula in Middle Level Education (both options) and from the course descriptions and change the course description and concurrent enrollment requirements of MLED 4023, Guided Field Experiences.
6. Change the course number of MLED 3071, Diversity in the Classroom, to MLED 3072.
7. Change the course number and title of MLED 3023, Nature and Needs of the Middle Level Student, to MLED 3024, Psychological Foundations for the Nature and Needs of Middle Level Students and delete MLED 3092, Psychological Foundations, from the required curricula (both options) and the course descriptions.
8. Change the course description of MLED 3034, Literacy Development in the Middle Grades and delete MLED 4012, Teaching Reading and

Student Strategies in the Content Area, from the required curricula (both options) and course descriptions.
9. Change the title of MLED 3041, Home-School Communication, to School to Home Communication, and change the course description.
10. Delete MLMS 4406, Integrating Mathematics and Science in Middle School Education, from the required curriculum in Middle Level Education in Mathematics/Science and from the course descriptions and add BIOL/PHSC 3003, Science in Elementary and Middle School Education, and MATH 3033, Methods of Teaching Elementary Mathematics, to the required curriculum.
11. Delete HIST 4963, Senior Seminar, from the required curriculum in Middle School Education in English/Social Studies and add HIST 2513, Sources and Methods in History, to the required curriculum.
12. Require ENGL 2043, Introduction to Creative Writing, in the required curriculum in Middle Level Education in English/Social Studies and delete the elective and its options (i.e., ENGL 2043, Introduction to Creative Writing, ENGL 2223, Introduction to Poetry, and ENGL 2263, Mythology).
13. Require three hours of a 3000-4000 level History course rather than three hours from HIST 4463, History of Russia, HIST 4603, The Modern Far East, or HIST 4703, History of Modern Africa (HIST 4803, Global Studies/Modern Times was deleted from the catalog in 2001).

Department of Art

1. Change the General Education requirement in Fine Arts for Art Education Majors to require ART 2123, Experiencing Art. (tabled 11/19/02)
2. Change the title of ART 3003, Art Education I, K-12, to Concepts in Art Education, and change the course description. (tabled 11/19/02)
3. Change the title of ART 3013, Art Education II, K-12, to Art Education Practicum, and change the course description. (tabled 11/19/02)
4. Add ART 2103, Art History I, World, as a core requirement and expand the art history course requirement from six to twelve hours for all art majors; modify the curriculum in Art for Teacher Licensure by: (a) adding ART 2103, Art History I, World, and ART 2113, Art History II, World; and (b) deleting three hours of electives and three hours of general art history. (Note: ART 2123 will serve as the fourth art history course.)
5. Change the prerequisites of ART 2503, Introduction to Opaque Painting, by adding the phrase "or permission of instructor."
6. Change the prerequisites of ART 3303, Drawing Studio I, by adding the phrase "or permission of instructor" and change the course description.
7. Change the prerequisites of ART 3533, Watercolor Painting, by adding the phrase "or permission of instructor," change the course description, and add a $\$ 30$ materials fee.
8. Change the title of ART 3603, Ceramics, to Introduction to Ceramics, and add a prerequisite of "ART 1403 or permission of instructor."
9. Delete ART 3613 as a course prerequisite for ART 4603, 4613, Ceramics Studio I, II (ART 3613, Ceramics Wheelthrowing, was deleted from the catalog during this past year).
10. Modify the curriculum in Fine Art by: (a) adding ART 2103, Art History I, World, and ART 2113, Art History II, World; and (b) deleting six hours of electives to account for the six-hour increase in art history hours.
11. Modify the curriculum in Graphic Design by: (a) deleting ART 3813, Printmaking Studio I; (b) adding three hours of art electives (3000-4000 level); (c) adding ART 2103, Art History I, World, and ART 2113, Art History II, World; and (d) deleting six hours of electives to account for the six-hour increase in art history hours.

Department of Social Sciences and Philosophy

1. Add HIST 4513, History of Science, to the course descriptions.

Department of Biological Sciences

1. Modify the curriculum in Physical Science and Earth Science for Teacher Licensure in the freshman year by: (a) deleting BIOL 1014, Introduction to Biological Sciences, and adding BIOL 1114, Principles of Biology; and (b) deleting Biology Electives (4 hours) and adding BIOL 1124, Principles of Zoology.

Department of Mathematics

1. Modify the curriculum in Mathematics for Teacher Licensure by deleting POLS 2003, American Government, and requiring HIST 2003, U.S. History to 1865 , or HIST 2013, U.S. History since 1865.
2. Change the number of MATH 1913, Precalculus, to MATH 1914 and change the prerequisites to "High School Algebra II and a Math ACTE subscore of at least 20 or a grade of C or better in MATH 0903."
3. Change the prerequisites of MATH 2914, Calculus I, to "MATH 1203 and MATH 1914 or a Math ACTE subscore of 23 or consent of the Math Department."
4. Change the course description of MATH 3243, Differential Equations I.

School of Community Education and Professional Development, School of Liberal and Fine Arts, School of Physical and Life Sciences, and School of Systems Science:
Addition of Minors in the following disciplines:
