A. Curricular Items

School of Business

- 1. Add COMS 1003, Introduction to Computer Based Systems, to all curricula in the School of Business.
- 2. Change the number of MGMT 3013, Management Productivity Tools, to MGMT 2013, and change the course description.
- 3. Replace BUAD 2003, Business Information Systems, with MGMT 2013, Management Productivity Tools, in all curricula in the School of Business.
- 4. Add COMS 1003, Introduction to Computer Based Systems, as a prerequisite for ACCT 2003, Accounting Principles I.
- 5. Change prerequisites for BUAD 2053, Business Statistics, from "MATH 1113 and/or 2243" to "COMS 1003 and MATH 2243."
- 6. Change prerequisites for BUAD 3023, Business Communications, from "6 hours of English Composition and BUAD 2003" to "6 hours of English Composition and COMS 1003."
- 7. Delete the "Vocational Business Education Elective" from the curriculum in Business Education for Teacher Licensure.
- 8. Add MGMT 4113, Managerial Issues in Electronic Commerce, to the course descriptions.
- 9. Change the appropriate footnotes to indicate elective hours to be earned in courses taught outside the School of Business: Accounting 7; Management and Marketing 4; and Economics and Finance 7.

Department of Curriculum and Instruction (pulled from consideration at December 10, 2002, meeting) (please refer to proposal copies previously distributed and to the additional material supplied by Dr. Bell included in this agenda)

- Delete ECED 3013, Technology in the Early Childhood Classroom, and MLED 3081, Instructional Technology, from the required curricula and course descriptions and add EDMD 3013, Integrating Instructional Technology, to the course descriptions and required curricula in Early Childhood Education and Middle Level Education.
- 2. Allow students in the Early Childhood Education and Middle Level Education programs to complete either GEOL 1004, Essentials of Early Science, or GEOL 1014, Physical Geology, in the required curricula.
- 3. Delete COMS 1003, Introduction to Computer Based Systems, from the required curricula in Middle Level Education in English/Social Studies and Mathematics/Science and add three hours of electives to the English/Social Studies curriculum and one hour of elective to the Mathematics/Science curriculum.

- Change the course number of MLED 2001, Introduction to Education, to MLED 2002 and change the course description and delete MLED 2011, History of Education, from the required curricula in Middle Level Education (both options) and from the course descriptions.
- 5. Delete MLED 3051, School Law, from the required curricula in Middle Level Education (both options) and from the course descriptions and change the course description and concurrent enrollment requirements of MLED 4023, Guided Field Experiences.
- 6. Change the course number of MLED 3071, Diversity in the Classroom, to MLED 3072.
- 7. Change the course number and title of MLED 3023, Nature and Needs of the Middle Level Student, to MLED 3024, Psychological Foundations for the Nature and Needs of Middle Level Students and delete MLED 3092, Psychological Foundations, from the required curricula (both options) and the course descriptions.
- 8. Change the course description of MLED 3034, Literacy Development in the Middle Grades and delete MLED 4012, Teaching Reading and Student Strategies in the Content Area, from the required curricula (both options) and course descriptions.
- 9. Change the title of MLED 3041, Home-School Communication, to School to Home Communication, and change the course description.
- 10. Delete MLMS 4406, Integrating Mathematics and Science in Middle School Education, from the required curriculum in Middle Level Education in Mathematics/Science and from the course descriptions and add BIOL/PHSC 3003, Science in Elementary and Middle School Education, and MATH 3033, Methods of Teaching Elementary Mathematics, to the required curriculum.
- 11. Delete HIST 4963, Senior Seminar, from the required curriculum in Middle School Education in English/Social Studies and add HIST 2513, Sources and Methods in History, to the required curriculum.
- 12. Require ENGL 2043, Introduction to Creative Writing, in the required curriculum in Middle Level Education in English/Social Studies and delete the elective and its options (i.e., ENGL 2043, Introduction to Creative Writing, ENGL 2223, Introduction to Poetry, and ENGL 2263, Mythology).
- 13. Require three hours of a 3000-4000 level History course rather than three hours from HIST 4463, History of Russia, HIST 4603, The Modern Far East, or HIST 4703, History of Modern Africa (HIST 4803, Global Studies/Modern Times was deleted from the catalog in 2001).

Department of Health and Physical Education

- 1. Add a prerequisite of "Admission to Stage II or permission from department head" to PE 4523, Measurement and Evaluation in Health and Physical Education.
- Add PE 4203, Methods of Teaching Adapted Physical Education in the Schools, to the course descriptions and replace PE 4103, Principles and Methods of Adapted Physical Education, in the Health and Physical Education Curriculum (including Teacher Licensure Requirements) with PE 4203, Methods of Teaching Adapted Physical Education in the Schools.

Department of English

1. Add minor in Creative Writing (tabled December 10, 2002) (please refer to the proposal copy previously distributed)

Department of Computer and Information Science

- 1. Change pre- and/or co-requisites for COMS 1201, 1301, 1401, 1403, 1521, 1561, 1903, 2003, 2104, 2163, 2203, 2213, 2223, 2233, 2333, 2503, 2703, 2713, 2723, 2803, 2981-4, 3163, 3213, 3333, 4033, 4043, 4053, 4103, 4133, 4203, 4253, 4303, 4403, 4603, 4703, 4803, 4981-3, and 4991-4.
- 2. Change the course description of COMS 4703, Data Communications and Networks.

Department of Mathematics

- 1. Add MATH 1111, College Algebra Laboratory, to the course descriptions and as a math requirement (pass/fail) for those students enrolled in MATH 1113, College Algebra, who had a 19 or 20 on the ACT math subscore (or equivalent score on another accepted test).
- 2. Change the course description of MATH 1113, College Algebra, by adding the following statement: "Students scoring 19 or 20 on the ACT subscore (or comparable other scores) must concurrently enroll in MATH 1111."

Departments of Foreign Languages and International Studies, Biological Sciences, Physical Sciences, Agriculture, and Parks, Recreation and Hospitality Administration

- 1. Change the computer science requirements as follows:
 - a. Change the computer science requirement in the International Studies curriculum from COMS 2003, Microcomputer Applications, to COMS 1003, Introduction to Computer Based Systems.
 - b. Change the computer science requirement in the Biology (Environmental Option) curriculum from COMS 2003,
 Microcomputer Applications, to Computer Science Elective (3 hours) with a footnote indicating that "COMS 2003 recommended."
 - c. Change the computer science requirement in the Geology (Environmental Option) curriculum from COMS 2003, Microcomputer Applications, to COMS 1003, Introduction to Computer Based Systems.
 - d. Change the computer science requirement in each of the following curricula to COMS 2003, Microcomputer Applications, or COMS 2803, Programming in C: Physical Science and Earth Science for Teacher Licensure (Chemistry, General, and Physics Options), Chemistry (General, Environmental, and A.C.S. Approved Options), Physical Science (General, Physics, and Nuclear Physics Options), and Engineering Physics.
 - e. Change the computer science requirement in each of the following curricula from COMS 2003, Microcomputer Applications, to COMS 1003, Introduction to Computer Based

- Systems: Agriculture Business (including Horticulture Business and Animal Science options) and Pre-Veterinary Medicine.
- f. Change the computer science requirement in each of the following curricula from COMS 2003, Microcomputer Applications, to COMS 1003, Introduction to Computer Based Systems: Recreation Administration Emphasis, Therapeutic Recreation Emphasis, Park Administration Emphasis, Turf Management Emphasis, Interpretive Naturalist Emphasis, and Hospitality Administration.
