- viii. Recruitment and Retention: Dr. Myers reported that faculty from every college, administration, and student government serve on this committee and will meet monthly with the charge to "Increase ATU enrollment though the university-wide coordination of student recruitment and retention activities." The first action item for the fall 2023 semester was to review the "early alert" program and to evaluate the current university wide retention initiative's: Strategic Enrollment and Recruitment Plan-Action Plan 2022-2025. Dr. Carey Ellis Laffoon is on this committee and will attend the upcoming October meeting.

New Business

- a. VPAA Update: Dr. Julie Furst-Bowe reported that internal searches for the three open college dean positions are underway and going well, along with the external search to fill the graduate dean position. Also, the Executive Committee is in the process of moving out of Tomlinson. Finally, three sabbatical applications were submitted and approved.

- c. Reduction in force policy: Dr. Newt Hilliard facilitated a conversation regarding the attached draft policy. He noted that this policy is a framework for the university to follow in case these issues come to pass. Faculty Senate will consider the final draft for approval at the November meeting. The Faculty Senate-approved policy will go to the ATU Board of Trustees for their consideration at the December meeting.
