Business Technology

Effective with the Summer I 2015 semester:

- Change the course title for BST 2113 from Word Processing II to Advanced Word Processing

Law Enforcement

Effective with the Summer I 2015 semester:

In the curriculum requirements for the AAS in General Technology with an emphasis in Law Enforcement:

- Delete the requirement for BST 2133 Multimedia
- Require 3 hours of Approved Elective Credit

Logistics Management

The Committee was asked to consider the addition of an Associate of Applied Science degree in Logistics Management pending approval by the Arkansas Tech University Board of Trustees and the Arkansas Department of Higher Education. The AAS degree would be effective with the Fall 2015 semester.

Registered Nursing

Effective with the Summer I 2015 semester, in the curriculum requirements for the AAS in Nursing:

- Accept either BIOL 2014 Human Anatomy and BIOL 3074 Human Physiology or BIOL 2404 Human Anatomy and Physiology I and BIOL 2414 Human Anatomy and Physiology II. (***Student must take either BIOL 2014 and BIOL 3074 or BIOL 2404 and BIOL 2414.***)
- Accept either 3054 Microbiology or 2054 Microbiology for Health Sciences

Motion by Cathy Rosewell, second by Lynn Washington to approve the changes requested by Registered Nursing. Motion carried.
