

Memorandum of Understanding for Articulation of Students

Arkansas Tech University

And

The Board of Trustees of the University of Arkansas acting for and on behalf of the
University of Arkansas Community College – Morrilton

The Memorandum of Understanding (“Agreement”), entered into by and between **Arkansas Tech University** (hereinafter, ATU), located at 215 West O Street, Russellville, Arkansas, 72801 and the Board of Trustees of the University of Arkansas acting for and on behalf of **University of Arkansas Community College – Morrilton** (hereinafter, UACCM), located at 1537 University Blvd., Morrilton, Arkansas 72110.

PURPOSE

The purpose of this Agreement is to facilitate the admission and transfer of eligible UACCM students into approved baccalaureate degree programs at ATU, as specified in the attached addenda. Both parties agree to offer students a seamless degree completion option to improve the economic status and employment opportunities available to citizens with a baccalaureate degree in the state of Arkansas and the nation.

AGREEMENT

It is agreed that any student who has earned an Associate of Arts or Associate of Science degree from UACCM will be eligible to transfer to ATU for an approved baccalaureate degree program with full junior classification upon admission, subject to the provisions listed below, in the attached program specific addenda, Higher Learning Commission requirements, in Arkansas Law, and in the Arkansas Department of Higher Education Transfer System.

ADMISSION REQUIREMENTS

1. ATU will maintain exclusive responsibility for admission.
2. The student must meet all criteria required for undergraduate admission to ATU.
3. The student must hold an Associate of Arts or Associate of Science degree from UACCM with a 2.0 cumulative grade point average, on or after the effective date of this agreement.
4. The student must meet the specific degree admission requirements for the chosen baccalaureate program of study at ATU.

TRANSFER OF CREDITS

1. Degree programs will be added as addenda to this parent agreement, as mutually agreed upon by the respective Chief Academic Officer at ATU and UACCM.
2. Specific course requirements for each approved degree program will be reviewed and agreed upon by the Division Chairs and Deans under whom the specific degree resides.
3. A grade of C or better is required to meet ATU's general education mathematics requirement and to satisfy transfer of Composition I and II.
4. ATU will accept grades of D for transfer; however, if the course description or degree program requires a grade of C or better, the student may be required to repeat that specific course. Arkansas Tech University accepts all grades of D upon admission; however, the percentage of courses with a grade of D may not exceed 25%.
5. Remedial course grades will not be computed in the cumulative GPA for purposes of admission to ATU.
6. The bachelor's degree with honors will be conferred upon candidates who at graduation have earned a minimum grade point average on all courses taken at Arkansas Tech as follows: Summa Cum Laude-3.900 - 4.000, Magna Cum Laude-3.700 - 3.899, Cum Laude-3.500 - 3.699. Graduation honors will be determined by work taken at Arkansas Tech only.

CONTINUITY

Students who have interrupted their attendance at Arkansas Tech University for more than one year or who have attended another university in the interim must reapply for admission. Additional documents are required for readmission.

IMPLEMENTATION AND REVIEW

Students will be subject to the terms and conditions of this Agreement in accordance with their academic year of entry at UACCM, not to precede the academic year during which the agreement first took effect. A student may opt for a subsequent revision of this Agreement, but must meet all of the requirements specified therein. A period of non-enrollment for 12 months or more would require the student to adhere to Agreement requirements corresponding to the academic year of re-enrollment.

ATU and UACCM will work cooperatively to make students aware of the opportunity provided by this agreement.

ATU and UACCM shall agree that no person shall on the grounds of race, color, national origin, gender, sexual orientation or creed be excluded from participation under the terms of this Agreement.

The Chief Academic Officers at each institution will implement the terms of this Agreement, including incorporation of any mutually agreed upon changes into subsequent revisions of this Agreement, assuring compliance with system policy, procedure and guidelines.

This Agreement will be reviewed on an annual basis, and ATU and UACCM will notify one another in a timely manner of any curriculum changes that would significantly impact the nature of this Agreement.

ATU and UACCM will work together cooperatively, in the best interest of affected students, to resolve any issues related to the transfer of courses should changes to either degree program occur while the Agreement is in effect.

Students will be subject to the terms and conditions of this Agreement in accordance with their academic year of entry at UACCM. A student may opt for a subsequent revision of this Agreement, but must meet all of the requirements specified therein.

ATU and UACCM will make every effort to inform students of this Agreement. This may include, but is not limited to, inclusion within each institution's website, university catalog, recruitment publications, media announcements, social media engagement, and in-person information sessions.

AMENDMENT

This Agreement may be amended upon mutual written agreement of the parties.

TERM OF AGREEMENT

This Agreement will be effective from the date of agreement indicated below and will be automatically renewed until terminated by either party. If either party wishes to terminate this agreement, they should do so in writing at least 90 days in advance of the requested termination date. The parties agree that any UACCM students enrolled at ATU at the time of termination of this Agreement shall be permitted to complete their degree under the terms of this Agreement.

The Agreement will be reviewed on an annual basis. Both ATU and UACCM agree to notify one another in a timely manner of any curriculum changes that would significantly impact the nature of this agreement.
