This letter is formal notification of the action taken by the Accreditation Commission for Education in Nursing (ACEN) at its meeting on March 9-10, 2017. The Board of Commissioners granted continuing accreditation to the master's nursing program and scheduled the next evaluation visit for Fall 2024.

Standard 6 Outcomes, Criterion 6.2

 Develop and implement a consistent documentation process for data collection and trending, faculty review of data, and use of data for decision-making.
