If the current state core General Education curriculum at ATU can be approved for fulfillment of as many of the new ATU experience requirements as possible, the majors should be able to cover the remaining ATU experience requirements to complete Gen Ed.

The new ATU experience requirements include the following: Technology, Civic Engagement, Diversity/Equity, Global Perspectives, Critical/Creative Thinking, Ethical Perspectives, Leadership, Wellness, and Financial Resources.

The following courses, if approved and assessed for additional credit as ATU experience courses, will maximize the ability of transfer students coming in with completed state core Gen Ed credits to meet the ATU experience portion of General Education without additional course work:

If the courses listed above can be approved to assess and fulfill the ATU experience requirements, students transferring with state core Gen Ed will automatically have fulfilled the technology, civic engagement, diversity/equity, critical/creative thinking, ethical perspectives, and wellness requirements of the ATU experience.

Most will also have been able to fulfill the global perspectives requirement as well.

However, many students will not have fulfilled the leadership or financial resources requirements in the ATU experience just by completing state core gen ed.

Therefore, individual majors will need to find ways to fill the leadership and financial resources requirements as part of the major. An easy way to do that is to get GE committee to accept required internships or capstones in a particular major to fulfill the leadership and financial resources portion of the ATU experience requirements.

## Majors – Leadership, Financial Resources

For ease of use in advising, the ATU experience courses will be tracked in Degree Works. For any transfer student whose courses do not fulfill ATU experience requirements, advisors will need to substitute existing courses, require that the student take additional classes, or complete approved co-curriculum to meet the requirements.

Courses not in the state core but equivalent to ATU courses approved by the GE committee for ATU experience may be used to fulfill ATU experience credit. For example, if foreign languages are approved for global perspectives at ATU, transfer students with any foreign language credit can get credit for global perspectives.

Department heads may also authorize substitutions to fulfill ATU experience courses in Gen Ed that are not equivalent of ATU courses, but for assessment purposes, they will need to document how the course or activity fulfills the ATU experience requirement.
