**Course Description:**  
*This course will provide the student nurse with the foundation of evidence based practice patient safety in women's health care through the exploration of patient safety bundles.*

**Course Objectives:** Upon completion of this course, students will be able to:

1. Investigate to better understand causation of harm in women's health.
2. Explore programs and tools to implement patient safety initiatives.
3. Explore the health care culture of respect, transparency, and accountability.
4. Examine the dissemination of patient safety information and education in professional nursing practice.

**Justification/Rational for the Course:****A. Relationship to ATU's Mission**

This course relates to ATU's mission of providing opportunity for intellectual growth, communication, analysis of data, and global issues.

**B. Relationship to Nursing Program's Mission**

This course relates to the program mission statements one through three.

**Course Policies****Attendance Policy:**

Students must sign in and complete the "Federal Attendance Module" required by the registrar at ATU on the first official start date of the course. If a student does not complete the "Federal Attendance Module" the student will be dropped according to the registrar's attendance policy. Students are expected to login to this BlackBoard course on the start date, completing assignments by each due date.

**Missed assignments** will be considered for completion (for uncontrollable circumstances) if the student makes prior arrangements with the course instructor before the assignment deadline or emails the instructor within 12 hours after the assignment is due. The course instructor will consider extending the deadline on an individual basis. Missed assignments may result in a reduction in that assignment grade or remain as an incomplete. Additionally, points/letter grade deduction is contingent on the quality of the work submitted by the student in meeting the requirements for that assignment. If additional time is granted to complete the assignment, the student has 24 hours to complete it or unless a due date is specified by the course instructor.

**Expectations of Students:**

Students are expected to participate in all course assignments. Grading rubrics are provided along with assignment expectations in Blackboard per assignment. Review the grading rubric and instructions prior to completing such assignment. APA format is required on all written assignments and references.

**Assignments/Presentations:**

It is required that each student *respond to two (2) postings* other than their own for minimal participation in the discussion boards (unless stated otherwise in the assignment instructions or grading rubric). Students will complete the assigned quizzes and discussion board questions. A reflection paper will be completed as a final assignment. Additionally, the Honors student will complete a paper/project agreed upon by faculty.

**ACADEMIC DISHONESTY**

**Academic Dishonesty.** Academic dishonesty refers to the various categories of cheating and plagiarism in the classroom.

1. Cheating on an examination, quiz, or homework assignment involves any of several categories of dishonest activity. Examples of this are: a) copying from the examination or quiz of another student; b) bringing into the classroom notes, messages, or crib sheets in any format which gives the student extra help on the exam or quiz, and which were not approved by the instructor of the class; c) obtaining advance copies of exams or quizzes by any means; d) hiring a substitute to take an exam or bribing any other individual to obtain exam or quiz questions; e) buying term papers from the Internet or any other source; and f) using the same paper to fulfill requirements in several classes without the consent of the professors teaching those classes.
2. Plagiarism is stealing the ideas or writing of another person and using them as one's own. This includes not only passages, but also sentences and phrases that are incorporated in the student's written work without acknowledgement to the true author. Any paper written by cutting and pasting from the Internet or any other source is plagiarized. Slight modifications in wording do not change the fact the sentence or phrase is plagiarized. Acknowledgment of the source of ideas must be made through a recognized footnoting or citation format. Plagiarism includes recasting the phrase or passage in the student's own words of another's ideas that are not considered common knowledge. Acknowledgement of source must be made in this case as well.
