

## 2023 Green & Gold Team Member Contract

In accepting membership of the Green & Gold Team, I understand that this position requires that I meet a certain set of standards. These standards have been established to ensure the best possible experience fornew students and their guests and to promote the feeling of camaraderie and support within the ATU Green & Gold Team, which is essential to a successful program. Please read the following statements and initial next to the number.

1. As a representative of the University, I will make every effort to present both ATU and myself in the best light possible. I will be aware that my actions could influence people's opinions of both the University and myself. I recognize myself as a role model. I will set a positive example for all new students by showing respect and consideration for all members of the faculty, staff, administration and university property.
2. I understand that my status as a representative of the University also extends to my social media presence. I will make every effort to ensure my social media profiles, pictures and comments adhere to the statement above.
3. I will attend all Green & Gold Training Sessions as well as all Orientation Leader Training sessions. These sessions will be held in-person in March and April and virtual in June & July.
4. During the summer months, I will check Slack and my ATU Email for updates on dates, times, and important changes for 2023 Orientation, as well as attend the mandatory, virtual trainings.
5. I understand that compensation for the Green & Gold Leader Position includes: a \$475stipend, some meals associated with the program, and staff apparel.
6. I will maintain good judiciary standing during my time as an Green & Gold Team Member. I promise to discuss any developing situations with my supervisors to prevent any unnecessary surprises regarding my standing. Any Conduct concerns will be handled on a case-by-case basis and could result in termination.
7. I understand I am expected to work the Admitted2ATU sessions on April 5, 12, 18, and 20. While class schedules will be accommodated, I understand I must request off for all other positions on these days to be available to work from 8am-5pm.
8. I understand I must be on campus and working as a Green & Gold Team Member from August 10-22, 2023. I will make the necessary adjustments to my schedule, so Orientation is my priority during this time.
9. I understand I am responsible for completing all HR paperwork before April 1, 2023.
10. I will maintain a 2.5 GPA during my time as an Green & Gold Member. I understand that I may be released from the Green & Gold team if my cumulative GPA is lower than the required 2.5 GPA after the Spring 2023 Term.
I understand that any and all violations of this contract are serious and will be dealt with on a case-by-case basis.
