# CURRICULAR ITEMS

Mr. Warden asked for action to approve the following changes requested by Air Conditioning and Refrigeration as listed below:

### **Business Technology**

Beginning with the Fall 2006 semester in the Business Technology curriculum requirements for technical certification:

• Replace BUS 1033 Administrative Support Procedures with BUS 1083 Introduction to Economics.

- Create and require CRT 1312 Air Brushing
- Delete CRT 1302 Body Frame and Alignment II from requirements

Beginning with the Fall 2006 semester in the Collision Repair Technology curriculum requirements for the Associate of Applied Science degree:

- Create and require CRT 1312 Air Brushing
- Delete CRT 1302 Body Frame and Alignment II from requirements

OTHER BUSINESS The suggestion was made that the committee consider curriculum changes only during the fall semester and no other meetings be held after December. This will provide a consistent time line for consideration of all programs in all departments. Other meetings could be held to address minor issues as we develop our structure and function, but curricular items should be addressed only once a year and be approved in time to print in the new catalog which is

printed in the spring semester. Motion by Willilam Nehus, second by Janet Mickens to approve the suggestion that the committee consider curriculum changes only during the

fall semester and that no other meetings be held after December except in the event that minor issues need to be addressed. Motion carried.
