**Allied Health**

ATU-Ozark Campus would like to delete the AAS in Allied Health with three different areas of concentration in Health Information Technology, Paramedic/Emergency Medical Services, and Practical Nursing and create three new separate AAS degrees in each of those areas: Health Information Technology, Paramedic/Emergency Medical Services, and Practical Nursing. This change would be effective with the Summer I 2013 term pending Board of Trustees and Arkansas Department of Higher Education approval. Since no curriculum changes are involved, students will seamlessly transition immediately into the new degree and major.

**Health Information Technology**

Effective with the Summer I 2014 semester:

In the curriculum requirements for the Technical Certificate in Health Information Technology and the AAS in Allied Health with a concentration of Health Information Technology:

- Change the name of HIT 1243 from Human Anatomy and Physiology to Human Anatomical Structure II

*This change will also be effective for the CP in Allied Health, AAS in Allied Health with concentration of Practical Nursing, the AAS degrees in Cardiovascular Technology, Medical Assisting, Occupational Therapy Assistant, and Physical Therapist Assistant.*

- Change the course descriptions for HIT 1123 and HIT 1243. The content of the two courses will be redistributed with the body systems being split between the two classes more efficiently for the health sciences programs.

Effective with the Summer I 2014 semester:

In the curriculum requirements for Associate of Applied Science in Allied Health with a concentration of Practical Nursing:

- Delete the requirement for LPN 1122 (which was approved at the 11-13-13 meeting to change to LPN 1103 but change was not implemented because of this action)
- Create and require LPN 1243 Human Anatomical Structure II

**Medical Assisting**

Effective with the Summer I 2014 semester:

In the curriculum requirements for Associate of Applied Science in Medical Assisting:

- Delete the requirement for BUS 1043 Professional Communication
- Delete the requirement for HIT 1103 Health Data Content and Structure
- Delete the requirement for HIT 1203 Computers in Healthcare
- Delete the requirement for INT 2903 Internship
- Create and require MA 2013 Medical Office Computer Systems and Insurance
- Create and require MA 2014 Medical Assistant Administrative Practice
- Create and require MA 2042 Medical Assistant
- Require INT 2904
- Change the course number and name from MA 2034 Medical Assistant Clinical Practice to MA 2033 Medical Assistant Practice
- Change the course name for MA 2032 from Medical Assistant Clinical Practice Laboratory to Medical Assistant Practice Laboratory
