- Change the course number for Emergency Medical Operations from EMTP 2212 to EMTP 2213 and increase the credit hours to 3
- Require HIT 1113 Medical Terminology
- Require HIT 1123 Human Anatomical Structure I
- Require HIT 1243 Human Anatomical Structure II

Motion by Ashley Gattis, second by Stan Hatcher to make the changes above in the Paramedic/EMS program. Motion carried.

Practical Nursing
