**CURRICULAR  
ITEMS**

Mr. Sikes asked for action to approve the following changes requested by the respective programs:

**Air Conditioning and Refrigeration**

Beginning with the Spring 2008 semester, in the curriculum requirements for the Associate of Applied Science degree for Air Conditioning and Refrigeration and the Facilities Management option:

- Change the course number for Boiler Operations from ACR 2125 to ACR 2134 and reduce the semester credit hours from 5 to 4

- Require AST 1003 Automotive Electronics
- Delete the requirement for WLD 1402 Welding for Trades and Industry

### **Industrial Control Systems**

Beginning with Spring 2008 semester, in the curriculum requirements for both the Technical Certificate and the Associate of Applied Science degree for Industrial Control Systems:

- Change all active ELT course prefixes to ICS course prefixes

### **Welding Technology**

Beginning with Spring 2008 semester, in the curriculum requirements for the Technical Certificate Welding Technology:

- Change the course name of WLD 1804 from Certification Welding to Certification Welding I

Beginning with Spring 2008 semester, in the curriculum requirements for the Associate of Applied Science degree for Welding Technology:

- Change the course number for Welding for Trades & Industry from WLD 1402 to WLD 1403 and increase the semester hours from 2 to 3
- Change the course name of WLD 1804 from Certification Welding to Certification Welding I
- Change the requirement from WLD 2904 Internship to WLD 2904 Internship or Approved Elective
- Create WLD 2804 Certification Welding I as an option for the approved elective
