### **NEW BUSINESS**

Heather Nelson, Logistics Management chair, presented a change to her current CP and proposed the addition of a new CP.

- For the current 12-hour CP, Nelson would like to remove BST 1303
   Into to Computers from the requirements and add LGM 2043
   Strategic Procurement. This course is an integral part of the logistics industry and includes an industry recognized certificate that will better serve the students.
- The new 6-hour CP in Transportation Management will reward high school students who are taking concurrent courses LGM 1013
   Principles of Logistics and Supply Chain Management and LGM 2023 Transportation Management (referred to as Supply Chain 1 and 2 in the high schools). This will make them eligible for a merit honor at graduation and encourage them to continue in the ATU-Ozark LGM program.
- It was mentioned that this 6-hour CP would be considered a Basic CP in the ATU structure and this brought up some concerns over what the high school definition of a CP is for the purpose of getting a merit honor. Nelson will obtain clarification and present via email to Curriculum Committee. An email vote will be initiated with the necessary information and new documents, if needed.
- Motion to table made by Koone, second by Maxwell. Motion carried.
