

**1.0 Summary of Work**

- 1.1** The scope of work for this project involves the removal and disposal of asbestos-containing materials as noted in contract specifications. This contract shall be considered fully complete upon the owner's acceptance of the closeout documents. The contract specifications and project drawings are designed to locate areas of work and identify work procedures. Discrepancies in the bid documents shall be resolved by EEG, Inc. after receiving a written request for clarification from the Contractor. All given quantities are estimated and the Contractor shall be responsible for verifying estimates.

**1.2 Scope of Work**

Contractor shall properly remove and dispose of the following asbestos-containing materials associated with the student union addition on the ATU campus in Ozark, Arkansas.

- approximately 2,000 square feet of sheetrock and spray-applied texture on the architectural fur down
- approximately 500 square feet of Soffit and fascia on the exterior
- approximately 350 linear feet of window glazing on the exterior windows
- The contractor should expect overspray on roof deck and penetrations.

The Contractor will erect a containment to isolate the work area. After the containment has been erected, the Contractor will HEPA vacuum and wet wipe the affected area. After having accomplished this, the Contractor will further isolate the intended work area. After containment critical barriers are in place, the Contractor shall remove the materials listed above and dispose of as asbestos-containing material.

A mandatory pre-bid will be held at 2:00 p.m. on Wednesday, September 8, 2010, at the student union addition of the ATU campus in Ozark, Arkansas. Plans and specifications may be obtained at Environmental Enterprise Group, Inc., 220 North Knoxville Avenue, Russellville, Arkansas, 72801 for a \$100 refundable deposit. Deposits will be refunded to unsuccessful responsive bidders who return the specifications to Environmental Enterprise Group, Inc.

Sealed bids will be received until 2:00 p.m. on Wednesday, September 15, 2010, at the Arkansas Tech Purchasing Office, 203 West "O" Street (Young Building east end), Russellville, Arkansas, 72801-2222. ATU will review the bid and will issue a notice of intent to award to the apparent low bidder. The contractor is to notify ADEQ immediately upon receipt of this notice.

**1.3 Special Project Consideration**

It is the intention of Arkansas Tech University to send the apparent low bidder a notification of intent to award letter on the day of the bid. The apparent low bidder must send in their notification to ADEQ on the day of the bid.

The Contractor awarded this project agrees to allow any federal or state inspector, acting in their official capacity, to have access to the job-site.
