#### **Grounds for Rejection of Proposals:**

ATU reserves the right to accept or reject any or all proposals and to waive formalities

Proposals that are substantially incomplete or lack key information WILL be rejected.

Late proposals will not be accepted and will be returned to the sender

#### Award:

#### **Contract Scope:**

Provide recruitment services in India/Nepal in order to increase the number of students studying at Arkansas Tech University. Services are to include, but not be limited to:

- a) Marketing of ATU in India/Nepal
- b) Recruitment of prospective students, both undergraduate and graduate
- c) Establishment of a reliable agent network
- d) Notifying university officials of current trends and issues associated with recruitment and marketing in India/Nepal
- e) Evaluation of documents submitted by applicants from India/Nepal
- f) Screening and interviewing all prospective students
- g) Provide pre-departure orientation and training for admitted students, including logistical support for travel
- h) Provide translation services as needed

#### **Assignment:**
