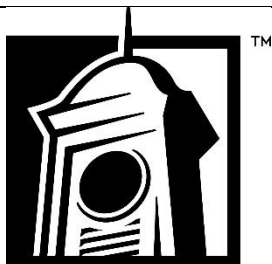

- Vaulted Ceiling Throughout
- 7/16" Zip System Roof decking
- Tamko 30-year Architectural Shingles- Weathered Wood color
- Primed Wood Siding (Ready to be Painted)
- 1- 30" Fiberglass Corner Shower Unit
- Plumbing "Roughed-In"
- Electrical Wiring "Roughed-In"
- Wired for Mini-Split HVAC unit
