

Update to Amazon Business Ordering Process

Exciting improvements are on the way for ATU's Amazon Business purchasing process. Soon, all Amazon orders will undergo review by the Procurement Office to ensure full compliance with state regulations and ATU's purchasing and PCard policies before being placed with Amazon.

Here's what you can expect:

- ✓ After submitting an Amazon Business order, you will receive an email confirmation summarizing your purchase.
- ✓ You will also receive a second notification once your order is released by Procurement for processing. A third email confirmation will be sent when your order ships.

Please remember:

- ✓ Moving forward, it is essential that all PCard purchases with Amazon be placed under ATU's Amazon Business account.
- ✓ If you are not yet registered for ATU's Amazon Business account, please contact Procurement at purchasing@atu.edu to get set up.

We appreciate your cooperation as we implement these changes to improve purchasing oversight and streamline order processing. Thank you for supporting ATU's commitment to responsible spending!
