In the virtual learning environment, except for the rare exceptions, writing is often the only way for a student to demonstrate they have met the learning outcomes. Two of the learning objectives for the Professional Studies degree are connected to student writing ability and success: 1) Student will demonstrate competency in public presentation and written communication skills, and 2) Student will create, plan, and implement relevant strategies needed to develop a business proposal. All learning outcomes in upper division Professional Studies courses require students to communicate effectively with the written word in a manner free of errors. The final three-course series in the Professional Studies Professional Core (PS 3143 Applied Professional Research, PS 3003 Project Design, and PS 4003 Capstone Project) require students to apply effective writing skills, combined with APA proficiency, to identify, design, and deploy a major research effort designed to address a real-world corporate, professional, or industrial challenge. PS 3143 Applied Professional Research requires mastery in the fundamentals of professional research, including identifying peer-reviewed scholarly resources, deploying the research process, ethics in research and reference citation models. PS 3003 Project Design provides an opportunity for the student to facilitate a process for identifying a particular problem in an actual business or industry environment relevant to the student's area of concentration. The end product required of the student is the development of a formal needs assessment, prioritized by feasibility, cost, and urgency. In PS 4003 Capstone Project, the student recommends relevant strategies, validates or rejects the plans selected based on a literature review, and presents a detailed continuous improvement plan, which must be approved and accepted by all relevant stakeholders.
