## For 2021-22 Catalog

### July

July 1, 2020 – Completed curriculum proposals and cosmetic changes to Assessment/Registrar

July 1-31, 2020 – Assessment/Registrar review proposals (*review for all required items, collect missing items, review proposals for mechanical accuracy, return inaccurate proposals for correction, summarize proposals, scan proposals to pdf, enter navigation bookmarks in pdf, post summary and proposals to Curriculum Committee web page*)

August, 2020 – General Education Committee (*Reviews proposals for new general education courses*)

August 3, 2020 – Curriculum Committee Agenda & Proposals posted on web for committee review

March 1, 2021 – 2021-22 Catalog Go Live

March, 2021-August, 2021 – Returning Student and Transfer Student Registration begins

March, 2021 – College and/or Department Curriculum Committee (*Review curriculum for changes for 2022-23 Catalog; consult Assessment prior to developing proposals; prepare White Paper for April deadline; and prepare curriculum proposal forms*)

## April

April 1, 2021 – Vice President for Academic Affairs approves White Paper

April 15, 2021 – President approves White Paper

April, 2021 – College and/or Department Curriculum Committee (*Review curriculum for changes for 2022-23 Catalog; consult Assessment prior to developing proposals; and prepare curriculum proposal forms*)
