### Parish Priests in Late Medieval Germany

- C. Purpose / Objectives
- **D.** Significance / Need: I address B., C., and D. in the following statement:

I have begun to revise my dissertation for publication. A publisher has expressed interest (see attached letter from Robert Bast) and I intend to travel to Germany in June, 2006 in order to complete additional archival research. I am requesting funds for airfare, travel and lodging within Germany, and copying costs.

Research in the religious history of Europe during the 16<sup>th</sup> and 17<sup>th</sup> centuries has long moved beyond studies of kings, popes and reformers to study the roles played by various social groups in embracing or resisting religious change. One group that has attracted recent attention is the lower clergy, made up of common parish priests, simple pastors, lowly local ministers, and village vicars. Historians have especially focused on how early-modern clerics—whether Catholic, Lutheran, Calvinist or Anglican—redefined their religious and professional identities in the light of the changes brought by the Protestant and Catholic Reformations and the so-called 'confessional age' (the period 1500-1700) (Dixon and Schorn-Schütte, 2003; Janse and Pitkin, 2006).

Less understood is the professional identity of the parish priest in the previous century: in many ways the 'base-line' from which to understand the changes of the 16<sup>th</sup> and 17<sup>th</sup> centuries.

My dissertation and subsequent research has sought to fill in this gap by studying the expectations placed upon parish priests in southern Germany during the 15<sup>th</sup> century and how these clerics negotiated their duties and status: that is, how these priests at the bottom of the ecclesiastical hierarchy interacted with the episcopal hierarchy above them and the patronage, parish and civic networks around them (Dykema, 1998; Dykema, 2000).

As I begin to revise my dissertation for publication, I must expand my source base. Two types of historical sources have served me well and I wish to further my use of them:

- 1. Manuals for pastoral care: guidebooks written by and for parish priests, these detail in simple language the liturgical and sacramental duties of the common priest. Often shortened and simplified versions of academic treatises, these manuals poured off the printing presses of the late-15th century. One of them, the *Manipulus curatorum*, became a bona fide best-seller, having been printed in 119 editions between 1460 and 1500. (I will be giving a conference paper on this work in the fall: see attached letter from Katharine Lualdi)
- 2. Endowment agreements: contracts between wealthy patrons and local priests to endow new clerical positions or to finance new priestly duties, whether sermons, memorial masses, or visits to a filial chapel. These agreements not only define the tasks to be carried out, but they also reveal characteristics desired in the priest as well as any demands raised by the clerical candidate. They are, in effect, job descriptions and negotiated contracts.

#### E. Process for Attainment of Objectives / Goals

The manuals for pastoral care are only available in early-printed editions, while the endowment agreements are manuscripts housed at various archives. I will pursue research in the

archive of the Gutenberg Museum in Mainz, the Wuerttemberg State Library and Archive in Stuttgart, and the University Library in Tuebingen, all cities in southwest Germany. I will locate materials and order reproductions in the form of photocopies, microfilm, or microfiche.

Finally, this research trip will benefit my students. I am a professor of European history yet have been unable to visit Europe since 1996. My teaching, as well as my research, will be invigorated by this visit. Round-trip airfare to Frankfurt now runs around \$1200 and lodging is not cheap. University support is necessary for me to pursue excellence in my research and teaching fields.

#### F. Dissemination of Results

My planned research will strengthen a presentation I will give at this fall's Sixteenth Century Studies Conference (SCSC). My paper will address late-medieval manuals for pastoral care (one specifically, the *Manipulus curatorum*) and their place in the print culture of the 15<sup>th</sup> century. More importantly, my research will allow me to revise and publish my dissertation in the near future. Dr. Robert Bast (Univ. Tennessee), the editor of the series Studies in the History of Christian Traditions (Brill Publishers), has shown interest in publishing my work. My research over the summer will enable me to shore up my source base and determine the needed revisions prior to submitting the manuscript for publication. See attached letter from Dr. Bast.
