#### B. Abstract

In August 2004, the River Valley Methamphetamine Project (RVMP) organized as a grassroots multi-faceted community action demonstration project to respond to the methamphetamine (meth) epidemic in Arkansas' 5<sup>th</sup> Judicial District which includes Pope, Johnson, and Franklin counties. The project included over 59 organizations, schools, law enforcement, mental health, child protection, faith based groups, and others. It was action based and focused locally upon increasing awareness about methamphetamine, reducing use, manufacture, and distribution of methamphetamine, and improving treatment for meth users (Wilkerson & Earnest, 2004). Although much was accomplished and the community became positively and collaboratively engaged in the RVMP, the project lacked a social science research component that provided an adequate knowledge base about the scope and depth of meth problems in the communities and counties of the 5<sup>th</sup> Judicial District. The current research proposal aims at answering questions about the scope and depth of the meth epidemic in the 5<sup>th</sup> Judicial District with implications for statewide replication of the River Valley Methamphetamine Project. Expected results include improved community law enforcement response and recommendations for treatment strategies for those affected by the methamphetamine epidemic.

#### C. Purpose/ Objectives

The purpose of the project is to close the knowledge gap regarding the underlying individual and social problems which complicate the multi-faceted methamphetamine epidemic in Arkansas.

The objectives of the project are: 1) To understand the scope and magnitude of public concern about meth for Pope, Johnson, and Franklin Counties in Arkansas, 2) To understand individual level reasons for meth production and use, 3) To determine the extent to which non-violent misdemeanors and felonies are associated with meth production or use, 4) To measure the extent to which current intervention strategies result in accomplished county-level goals for reducing meth production and use, and 5) To understand and facilitate community action as a response to meth use as well as offer recommendations and alternative strategies for identification and intervention of community and individual level problems.

#### D. Significance / Need

Nationwide, methamphetamine has been declared a problem of epidemic proportions.

Likewise, in Arkansas, methamphetamine-related problems are viewed as epidemic. The 
National Drug Threat Assessment lists Arkansas as one of the central states along with Missouri, 
Iowa, Indiana, and Illinois that collectively constitute a primary market for meth due to high 
demand and extensive regional distribution (U.S. Department of Justice, 2004). The Arkansas 
Drug Threat Assessment (U.S. Department of Justice, 2003) identified methamphetamine as a 
threat primarily due to ready availability.

Pope County, Arkansas, is a rural county located in northwest Arkansas and claims a population of approximately 55,000 of Arkansas' approximately 2.6 million residents (U.S. Census Bureau, 2000). Russellville is the county seat of Pope County, population 23,682, and is

the home base of the 5<sup>th</sup> Judicial District. It is also the home of Arkansas Tech University, which increases the city's population during the academic year by approximately 1,500 young adults (J. W. Watson, Arkansas Tech University, personal communication, December 2, 2004).

In the 5th Judicial District, in 2003 and the first five months of 2004, 52% of all felonies filed in the district involved either the use, distribution, or manufacture of meth. Between 1997 and 2003 there was a 114.6% increase in the number of methamphetamine cases filed in the district. When the focus narrowed to manufacturing cases (manufacture and possession of paraphernalia with intent to manufacture), the increase went from nine cases in 1997 to sixty-seven cases in 2003 – a 644% increase. In the first five months of 2004, there were 36 meth manufacturing cases filed (David Gibbons, Prosecuting Attorney, 5<sup>th</sup> Judicial District, personal communication, December 8, 2004).

While law enforcement agencies have been burdened by the meth epidemic, treatment programs and service agencies have also felt the impact of increased meth use. For example, in 2004, the local residential substance abuse facility indicated that approximately 80% of their population had meth related problems and the mental health clinic reported that over 50% of the clients treated had meth related problems (Wilkerson & Earnest, 2004).

This research project will contribute to the fields of sociology, criminal justice, and rehabilitation through obtaining quality information and knowledge which will serve to guide grassroots organizing and law enforcement efforts to contain the growing social problem often referred to as the "meth epidemic".

#### E. Process for Attainment of Objectives/ Goals

Faculty researchers will conduct this research project. This project will include: 1) a survey of the general population of Pope, Johnson, and Franklin Counties to assess public

concerns over multiple issues including meth use and production, 2) Face to face interviews with inmate and bonded or released population to assess motivation, behaviors, and estimates of use and production of meth in Pope County (no student participation), 3) Assessment of background characteristics of those seeking treatment through review of secondary sources, and 4) Face to face interviews with treatment professionals through a "referral" technique to assess the adequacy of treatment offered in the community (See the attached Human Subjects approval statement in appendix A).

ATU students enrolled in SOC 3163 "Introduction to Social Research" (Sean Huss) and SOC/CJ 3153 "Prisons and Corrections" (Terri Earnest) during the spring semester, 2006, will be involved in survey development, selection of random samples, secondary data input and analysis, survey administration, and on a very limited basis, interviews with treatment professionals in the community. Faculty will illustrate experiential and collaborative teaching through innovative teaching strategies involving multiple classes and the grassroots community organization (RVMP).

#### F. Dissemination of Results

Results will be shared with members of the River Valley Meth Project in May, 2006.

Articles will be submitted to refereed sociological, criminal justice, and rehabilitation journals.

Findings will be shared with the University of Arkansas for Medical Sciences (UAMS) Center for Alcohol and Drug Abuse, with the Arkansas Drug Director, with academic colleagues at the University of North Florida, and others as funding permits.
