Abstract

I was invited by Drs. Geraldine Lee-Treweek of Manchester Metropolitan University and Brinda Jegatheesan of the University of Washington to speak at the 7th International Conference on Social Science Methodology on September 1-5, 2008, in Naples, Italy. My presentation will be titled "Ethical Examinations of Elder Abuse: Using Literary Ethnographies to Explore the Maltreatment of Vulnerable Populations".

The research behind this presentation concerns examining the social worlds of certain vulnerable populations. Such research can be problematic when people are located in institutional settings with agents of control skeptical of researchers from the outside coming in and observing behavior. When gatekeepers block access and a researcher wants to examine a delicate topic, one ethical, highly feasible way to paint an interpretive picture of everyday life for vulnerable populations involves the use of a literary ethnography. With data from research on elder neglect and abuse in United States nursing homes, the presentation will detail the six-stages of a literary ethnography. It will conclude with a discussion of literary ethnography weaknesses and directions for future applications. Attending this conference will allow me to expose my research at Arkansas Tech University to international colleagues in the field of sociology. It will also allow me to expose an international audience to the research behind a book I am currently working on for Paradigm Publishing - Elder Care Catastrophe: Understanding Rituals of Abuse in Nursing Homes.

Purpose/Objectives

The primary purposes of this conference presentation are furthering my research agenda and promoting a positive image of Arkansas Tech University in international academic circles. My research currently focuses on maltreatment of vulnerable populations. Attending this conference will enhance my knowledge of research methodology, teaching effectiveness, and classroom performance.

Significance/Need

As mentioned, attending this conference is significant because it will allow me to share my research with international colleagues in the field and bring back knowledge to share with students at Arkansas Tech University. I will not be able to attend this conference without the support of professional grant funding. My \$600 of departmental and Liberal and Fine Arts money will not be available. It will be used for attending and presenting at the upcoming American Sociological Association conference.

Process for Attainment of Objectives/Goals

I will travel to Naples, Italy on August 31, 2008. I will attend the 7th International Conference on Social Science Methodology on September 1-5, 2008. The conference will be held at the Campus di Monte Sant'Angelo in Naples, Italy.

Dissemination of Results

Aspects of the presentation will be included in my upcoming book *Elder Care Catastrophe: Understanding Rituals of Abuse in Nursing Homes* (Paradigm Publishing).
