#### **B.** Abstract

The Association of Teacher Educators was founded in 1920 and is an individual membership organization devoted solely to the improvement of teacher education both for school-based and post secondary teacher educators. ATE members represent over 700 colleges and universities, over 500 major school systems, and the majority of state departments of education. The ATE office is located in the Washington DC area where it represents its members' interests before governmental agencies and education organizations. In addition, ATE has representatives on the National Council for Accreditation of Teacher Education (NCATE) and the Holmes Partnership.

The Association of Teacher Educators (ATE) holds its Annual Conference in February .The 2009 Annual Conference will be held in Dallas, Texas. There are Pre-Conference workshops and I am a member of the ATE Leadership academy that meets prior to the opening of the conference. The general session includes leading educators and legislators that address current educational issues and trends.

## C. Objectives

To identify how middle level teacher education programs address self-efficacy and disposition of the pre-service teacher.

To share available assessments that measure middle level pre-service teacher's self-efficacy and disposition prior to and during the internship.

# D. Significance/Needs

The developmental characteristics of the young adolescent create an urgent need for middle level teachers to recognize the broad range of student learning needs in the classroom. Recognizing that the job of the middle level teachers is difficult at best, it is important that pre-service teachers demonstrate and understand the importance of having a positive disposition and also recognize that their self-efficacy is an important part the young adolescent's achievement and learning. The pre-service teacher's disposition in the classroom affects their view of self-efficacy and how it relates to their own behavior in the classroom. Defining self-efficacy with the middle level pre-service teacher is important, as is how Middle Level Teacher Education

programs develop assessments that measure theses important characteristics of the middle level pre-service teacher.

# E. Process for attainment of Objectives/Goals

Research on disposition and self-efficacy will be presented leading into a discussion of assessment instruments that are used in the ATU Programs and those by other universities attending the session.
