### Abstract:

The National Recreation and Parks Association (NRPA) Congress and Expo is an annual conference and trade show. The event was attended by well over 4,000 recreation and park professionals, students, and faculty members. It served as an excellent opportunity to network with recreation and park professionals in the field and faculty. This conference provides the opportunity to recruit potential work experience and internship sites for the ATU Recreation and Parks Program. There were also a number of educational sessions that focused specifically on the Council on Accreditation of Parks Recreation, Tourism, and Related Professions Accreditation Standards. These educational sessions were very much of interest and importance to me as our RPA program is an accredited program and it appears that the accreditation standards are changing rapidly. I also took a group of 6 RP students to the conference; this allows the students to gain knowledge about their chosen profession and seek opportunities for work experience and internship.
