Can someone provide the verbiage to explain to	Differential fees are broken down into two parts.
the students differential fees?	1) The course fee is like levelized billing. It will help students predict the cost of tuition for the next 4 years.  2) Will depend on the degree field you choose. Some degrees cost more due to labs, equipment, etc. It is a way to fairly charge students based on the degree path they have chosen and how much they could potentially make in that field. Fees will be added once they have taken gen ed courses. Meaning there is no increase to gen ed classes. Over the next 4 years, the max a student
	could potentially see increase, is 2%.
Why is Midtown not open in RCB during the summer?	Midtown said that it is not cost efficient for them to be open during the summer.
