Transfer Policy Electrical and Mechanical Engineering Departments - Proposal -

- 1. Upper level engineering courses (3000 and 4000 level) are transferable from ABET accredited institutions accredited by the Engineering Accreditation Commission (EAC).
- 2. Engineering senior design course credits are not transferable.
- 3. No more than 12 credit hours of the required 3000 4000 level engineering, engineering elective or technical elective course credits may be transferred.
- 4. All transfer courses from U.S. universities must be from institutions of higher education which have been accredited by a regional accrediting agency.
- 5. Courses presented for transfer credit from non-U.S. institutions which are not ABET accredited must be accompanied by supporting materials such as course outlines, catalog descriptions, and, possibly, examples of student work, tests, etc. All such supporting material must be presented in English and must also meet any additional requirements imposed by the Office of Admissions and the Registrar. Arkansas Tech University requires the applicant to submit his/her academic credentials to a credential evaluation service. Preapproved courses from institutions in the ATU Study Abroad Program are exempt from these requirements.

Tammy,

I need your assistance with this one. We have not been enforcing that students can only receive credit in one subject area nor that the department has to approve the credit can count towards the degree. I was not aware this was a policy. We just look for no more than 30 hours of exam and military hours. Tons of students have not met this policy. It is common for them to have CLEP for HIST 1503 and 1513 as well and both COMP I & II. Is this something we ask to be changed in the next catalog. Here is the full policy as state in the catalog:

College Level Examination Program (CLEP)

CLEP allows students to earn credit toward graduation by attaining Tech's qualifying score on either the general and/or subject examinations. Credit earned through CLEP may satisfy general education requirements. No more than one subject examination may be taken in a particular departmental area, and students must have prior approval from the department in which they are majoring to count the hours toward graduation. It is recommended that an ACT sub-score of 24 or above or an SAT sub-score of 500 or above be used as a guideline for attempting to earn credit through CLEP. Following are the CLEP examinations that Tech will accept, the corresponding qualifying score required, and credit awarded.
