The meeting was **called to order** by Dr. Eldon Clary, Dean of the College of Education at 4:00 p.m. The persons present introduced themselves before the proposals were made. The following proposals for 2012-13 catalog were brought before the council for discussion, motions, and approval.

First, the **College of Arts and Humanities, Department of English and World Languages** proposed:

- (a) Modify the curriculum in Foreign Languages with Concentration in Spanish for Teacher Licensure as follows:
 - (1) Delete 2 hours physical activity;
 - (2) Allow SPH 2003, Public Speaking, to satisfy general education speech communications selection;
 - (3) Add TECH 1001, Orientation to the University;
 - (4) Adjust electives from 13 hours to 12-13 hours;
 - (5) Require SPAN 3123, Spanish Civilization and Culture, and SPAN 3133, Spanish-American Civilization and Culture; and
 - (6) Delete SPAN 3023, Introduction to Linguistics;
 - (a) Add TESL 6863, TESOL Practicum, to the course descriptions.
 - (b) Add ENGL 6863, TESL Practicum, to the course descriptions.
 - (c) Modify the curriculum in Master of Arts in Teaching English to Speakers of Other Languages as follows:
 - (1) Reduce the program to 30 hours;
 - (2) Remove the restriction against "C" grades being used in degree;
 - (3) Allow use of ENGL prefixed courses to substitute for equivalent TESL prefixed courses; and
 - (4) Add a comprehensive examination requirement.

Dr. Brucker orally presented the proposal. Questions were asked and answered concerning an explanation of TESL changes. A motion was made by Dr. Linda Bean and seconded by Dr. Annette Holeyfield to accept the proposal. Dr. Clary called for the vote. All members voted in the affirmative.

Next, the **Department of History and Political Science** proposed:

- (a) Change the course number for HIST 4713, Social Studies Methods for Secondary Teachers, to 4714, Social Studies Methods for Secondary Teachers; and
- (b) Modify the curriculum in Social Studies Education as follows:
 - (1) Delete 2 hours physical activity;
 - (2) Allow SPH 2003, Public Speaking, or SPH 2173, Business and Professional Speaking, to satisfy general education speech communications selection;
 - (3) Add TECH 1001, Orientation to the University;
 - (4) Decrease electives from 4 hours to 3 hours; and
 - (5) Replace HIST 4713, Social Studies Methods, with HIST 4714, Social Studies Methods.

A motion was made by Dr. Linda Bean and seconded by Dr. Mary Gunter to accept the proposal. Dr. Clary asked for discussion and there was none. Dr. Clary called for the vote. All members voted in the affirmative.

Third, the **Department of Speech, Theatre & Journalism** proposed:

- (a) Modify the curriculum in Speech Education as follows:
 - (1) Delete 3 hours physical activity;
 - (2) Allow SPH 2003, Public Speaking, to satisfy general education speech communications selection;
 - (3) Add TECH 1001, Orientation to the University;
 - (4) Delete SPH 2111, Debate Practicum, and SPH 2121, Debate Practicum, requirements;
 - (5) Delete one (1) hour of required speech or theatre elective;
 - (6) Delete HLED 1513, Personal Health and Wellness, requirement;
 - (7) Require TH 4263, Theatre History I: Antiquity to 1564, and TH 4273, Theatre History II: 1564 to 1900; and
 - (8) Add SPH 3003, Interpersonal Communication, requirement.

A motion was made by Dr. Linda Bean and seconded by Dr. Annette Holeyfield to accept the proposal. Dr. Clary asked for discussion and Dr. _____ explained the rationale for making the changes as connected to passing the Praxis II Content Knowledge. Dr. Clary called for the vote. All members voted in the affirmative.

Fourth, the **College of Applied Sciences, Department of Agriculture** proposed:

- (a) Add AGED 3013, Farm Management, to the course descriptions; and
- (b) Modify the curriculum in Agriculture Education as follows:
 - (1) Delete 2 hours of physical activity;
 - (2) Allow SPH 2003, Public Speaking, to satisfy general education speech communications selection;
 - (3) Add AGBU1001, o the University;
 - (4) Delete BIOL 2124, Principles of Zoology;
 - (5) Add AGPS 3044, Plant Propagation;
 - (6) Delete AGBU 4033, Agriculture Farm Business Management; and
 - (7) Add AGED 3013, Principles of Farm Management.

A motion was made by Dr. Linda Bean and seconded by Dr. Annette Holeyfield to accept the proposal. Dr. Clary asked for discussion and Dr. Justin Killingsworth explained the rationale for making the changes. No questions were asked, so Dr. Clary called for the vote. All members voted in the affirmative.

Fifth, the **College of Business, Department of Management and Marketing** proposed:

- (a) Modify the curriculum in Business Education as follows:
 - (1) Delete 2 hours physical activity;

- (2) Allow SPH 2003, Public Speaking, or SPH 2173, Business and Professional Speaking, to satisfy general education speech communications selection;
- (3) Change BUAD 1003, Introduction to Business, to BUAD 1001;
- (4) Delete MGMT 2013, Management Productivity Tools; and
- (5) Add BDA 2003, Business Problem Solving.

A motion was made by Dr. Linda Bean and seconded by Dr. Mary Gunter to accept the proposal. Dr. Clary asked for discussion and there was none. Dr. Clary called for the vote. All members voted in the affirmative.

Last, the **Graduate College, Center for Leadership and Learning** proposed:

- (a) Change the course number for EDLD 6992, Professional Portfolio, to EDLD 6991; and
- (b) Modify the curriculum in Masters of Education in Educational Leadership as follows:
 - (1) Reduce the program from 38 hours to 34 hours;
 - (2) Delete EDLD 6303, Technology as an Administrative Tool; and
 - (3) Change EDLD 6992, Professional Portfolio, to EDLD 6991.

A motion was made by Dr. Linda Bean and seconded by Dr. Gleason to accept the proposal. Dr. Clary asked for discussion. Dr. Chadwick and Dr. Gunter explained the rationale for making the changes. Dr. Clary called for the vote and all members voted in the affirmative.

Dr. Clary asked for **Other Business** and there was none. He discussed some of the licensure changes that are being proposed at the state level. This discussion was informational and did not require any action by the Teacher Education Council.

A motion was made by Dr. Linda Bean that we adjourn and it was seconded by Dr. Gleason. Dr. Clary called for the vote and all members voted in the affirmative. Dr. Clary **adjourned** the meeting at 4:45.
