

# Applying for Provisional Licensure

Note: Before Beginning the process for a provisional license, you must have a job offer.

#### What is a Provisional License?

A provisional license is a "temporary" license that lets a person teach as a teacher of record while completing the remaining requirements for a standard license. If approved, the provisional license is effective for two years provided that eligibility requirements are maintained.

#### What do I need to be eligible for a provisional license?

- o Copies of Transcripts for both undergraduate and graduate work.
- o Passing Praxis subject assessment(s) for your content area
  - Go to <a href="https://www.ets.org/praxis/ar/requirements">https://www.ets.org/praxis/ar/requirements</a> for information about Praxis requirements.
- Approved Background Check
  - This includes both criminal history and child maltreatment registry check less than one year old at the time of licensing.
  - You can check your background check status at <a href="https://aels.ade.arkansas.gov/AELS/Search.aspx">https://aels.ade.arkansas.gov/AELS/Search.aspx</a> - Use the last four of your SSN and your last name to search for yourself.
  - If your background check is more than a year old, please follow <u>these instructions</u>.

#### To remain eligible for a provisional license, you must:

- Be continually enrolled and in good standing in your program of study
- Maintain employment at the school for which the provisional license was issued.

### To apply for a Provisional License:

- Upload and send as a "packet" your:
  - IDEA professional development certificates
  - ProEthica certificate of completion
  - Copy of intent to hire or contract from the district
  - Copy of passing Praxis subject assessment score(s).
- o Make sure you have sent DESE (ADE) official undergraduate and graduate transcripts.
- Complete the online application for provisional license by loggin on here <a href="https://adeaels.arkansas.gov/AelsWeb/Account/TeacherLogin.aspx">https://adeaels.arkansas.gov/AelsWeb/Account/TeacherLogin.aspx</a> and select Applying for Provisional License.
- O What type of provisional license are you seeking?

- Provisional Non-Traditional MAT
- Select your Education Preparation Program
  - Arkansas Tech University
- o Verify your profile information is accurate and complete
  - Update if necessary
- o Review application information, electronically sign, and submit.

Dr. Bell will verify your eligibility to apply for a provisional license and will forward the required supporting documents and application to the Division of Elementary and Secondary Education. Allow **2-3 weeks** for your application to be processed and your license issued.
